The Directors consider that the proposed resolutions contained in the notice of AGM are in the best interests of the Company and shareholders as a whole, and unanimously recommend that you vote in favour of them, as they intend to do in respect of their own shareholdings.

Proxy Voting

You will not receive a hard copy form of proxy for the 2023 AGM in the post. Instead, you are encouraged to vote electronically using the link at www.signalshares.com. You will need to log into your signal shares account or register if you have not previously done so, to register you will need your investor code, this is detailed on your share certificate or available from our registrar, Link Group. The proxy voting should be completed in accordance with the notes set out in the AGM Notice and votes must be received no later than 10:00 a.m. on 18 May 2023.
